According to the Terms & Conditions of the lease agreement from MIDC, an extension of time limit is also been granted to the company under Udyog Sanjivani Scheme to obtain the Building Completion Certificate by 31st Jan 2017.</p> <p>However, the Investor was unable to complete the required construction work at the plant site and made an online application dated 10th August 2021 to MIDC for extension of time again, the same was rejected by MIDC office with the letter dated 18th August 2021 mentioning that there is no provision to further extend the time period and also allotment to the company stands cancelled.</p> <p>Further, the investor had approached then Hon'ble Minister Industries on 28th August 2021 with a letter requesting his intervention in getting the time period extended from MIDC on which Hon'ble Minister Industries has put a note directing Regional Officer, Nashik to provide a paid extension to the company. Now, the Investor is requesting to cancel the letter dated 18th August 2021 from Regional Office by giving the reference of the comments put by Minter Industries.</p>	<p>Hon'ble DC (Ind) has spoken to the concerned Dy.
