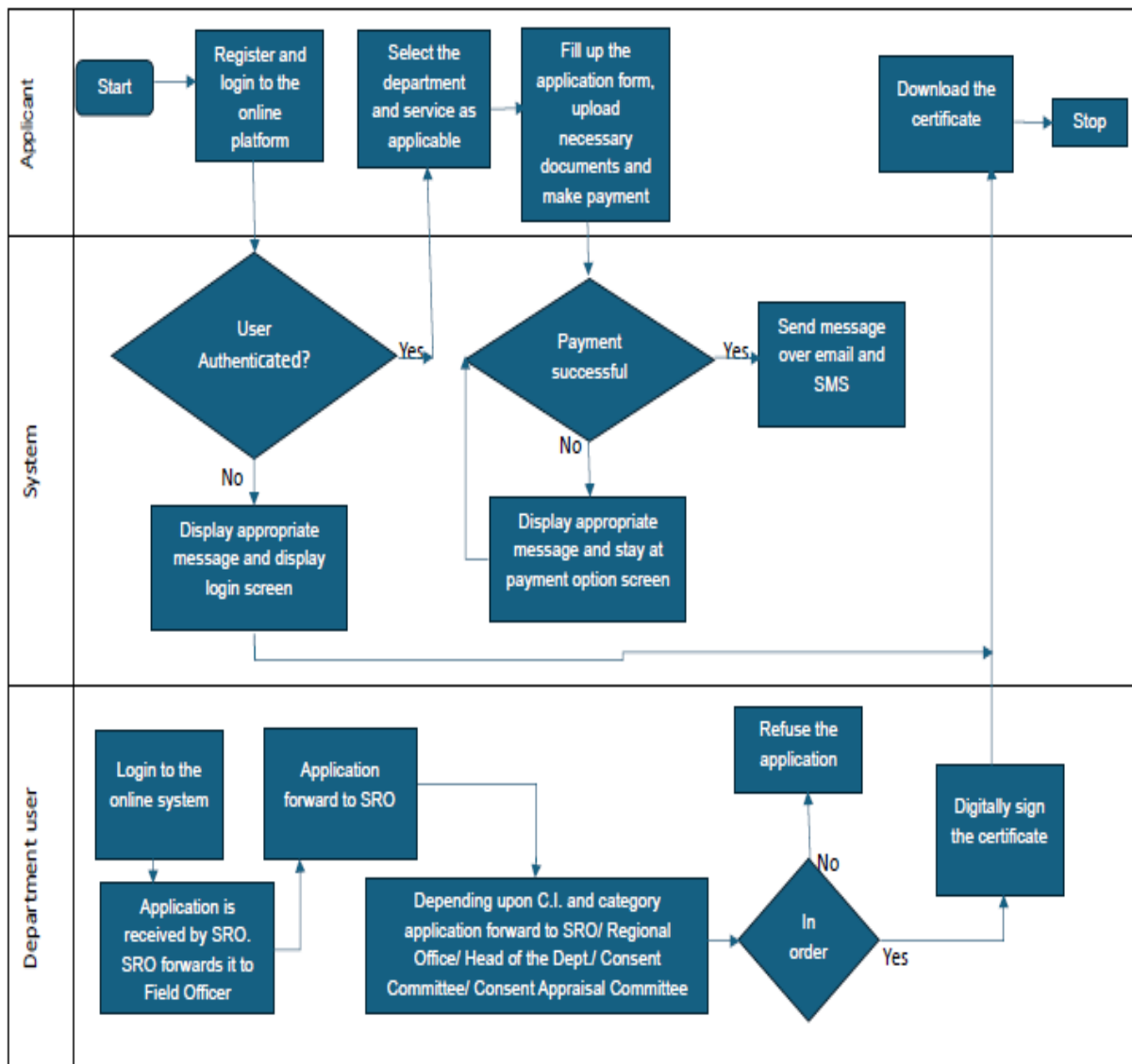

**Note:**

- Where Stringent legal action like prosecution/ Final closure direction have been given in the past one year, the cases of grant of renewal will be referred to next higher authority for all category of industry for grant or refusal of consent.
- The cases involved in any court case, in ecological fragile areas like Dahanu, Matheran, Mahabaleshwar, Panchgani, Murud Jangira etc, Bhatsa area shall be dealt at HQ level with approval of Member Secretary.
- Cases of Consent of Recycler/ Re-processor of Hazardous Waste, Plastic & E-waste shall be dealt by RO (HQ) and Authorization of Recycler & Re-processor of Hazardous Waste, E-waste & Registration of Plastic Industries shall be dealt by RO (HQ) with approval of Member Secretary.
